This will be conveyed to the technically qualified bidders automatically through an e-mail message on their e-mail address. The financial-bids shall be opened accordingly online on the same portal at O/o Chief Engineer (Distribution), Kashmir Power Distribution Corporation Limited (KPDCL), Exhibition Ground Jehangir Chowk Opp: J&K High Court, Srinagar-190001, Jammu & Kashmir.

The e-Bids will be electronically opened in the presence of bidder's representatives, who choose to attend at the above mentioned venue, date and time or any subsequent day to the convenience of the tender opening committee. An authorization letter of bidder's/OEM representative will be required to be produced at the time of Bid Opening.
8. KPDCL reserves the right to cancel any or all the e-Bids/ the e-Bid process without assigning any reason thereof. The decision of KPDCL will be final and binding.

9. In the event of date specified for e-Bids opening being declared a holiday then the due date for opening of e-Bids shall be the following working day at the appointed time and place.
10. All the required documents should be uploaded by the bidder electronically in the PDF format. Price Schedule/BOQ should be uploaded electronically in the same BOQ sheet provided with the SBD.
11. To participate in e-bidding process, bidders have to get 'Digital Signature Certificate (DSC)' class III (b) as per Information Technology Act-2000, to participate in online bidding.
